I hope that you are well aware of the fact that the Central Finance Ministry is repeatedly voicing for the grant of Education Loans without insisting Colletral security .The above refered application has been made requesting Education Loan to the said bank,which was received in the said bank on The Loan applied for has not so far been granted .Nor no information from the said Bank. I am therefore forced to request your good office to be pleased to furnish me certain informations,under the Right to Information Act.,2005.

- 1) I may kindly be informed the number assigned to the above refered Education Loan application by the said Bank to-gether with a copy of the register relevant page in which the above refered Education Loan application was registered by the said Bank and the date of which it was received in the said Bank.
- 2) A copy of the circular or instructions issued by your office or by your higher offices about the procedure to be followed in processing the Education Loan Applications and also the period with in which decision should be taken on the Education Loan Applications received by the respective Branch of your Bank.
- 3) A copy of the entire file with note file in which the above Education Loan Application was dealt with in the said Bank may be supplied to me.
- 4) I may kindly be informed the name and official designation of the bank Officials who handled the said Education Loan Application from the date of its receipt to this date
- 5) I may kindly be furnished a copy of the relevant portion of rule or some other orders which did not permit the said Bank to sanction Education Loan in this case till this date.
- 6) I may also kindly be informed the nature of the formalities still to be observed by the applicant to get the Education Loan applied for.

7) Since the loan applied for, in the said application has not been sanctioned or silently denied, such act of the said Bank ruins the future of the student concerned. Therefore, I may kindly be informed the nature of action which warrants against the officials who are responsible for such denial and delay, which are all against to the instructions of the Govt., of India and the RBI.

8) Kindly furnish me the detailed postal addresses of the persons in respect of whom Loan for Agri., purposes have been waived as per the orders of the Govt. of India, together with the quantum of principal and interest waived to each of them and the survey number and village of the land to which such loans were originally granted to each of them, by the said Bank

9) I may also kindly be informed me the name of the Bank Officials who granted such waived Agri. Loans with their present designation, postal addresses and residential address if retired from service.

10) Please also inform me the Designation and Postal Addresses of the first and second appellate authorities in case, if your reply is not satisfied or not received within the time stipulated.
